

The Alcohol Policy of First and Third Trinity Boat Club

1 First and Third Boat Club Dinner Alcohol Policy

- Any member of the party bringing alcohol into the dinner will have it confiscated.
- If an attendee is found to be consuming alcohol which was not provided by the venue during the dinner, they will have it confiscated, be asked to leave the dinner and not be permitted to attend the next dinner.
- If an attendee is drunk upon arrival for the dinner they will be turned away.
- Any anti-social behaviour during the dinner towards other diners will result in a warning. If the behaviour of the individual continues to disrupt the dinner they will be asked to leave.
- Any anti-social behaviour directed towards the staff or venue will result in the attendee immediately being asked to leave and the attendee not being permitted to attend the next dinner. For such cases in a Michaelmas BCD the attendance to Mays BCD will be at the discretion of the Captain and Secretary. In the case of any such instances, the Boat Club, additionally, must expect the matter to be reported to the Dean of College as a matter of course.
- Half a bottle of wine per person will be provided with the dinner. Where the venue can accommodate, the wine will be poured by staff.
- It will not be possible for attendees to purchase additional alcohol at the dinner.
- The Boat club does not endorse 'after parties' or excessive drinking after dinner.
- Two named members of the Committee will be nominated to ensure that the venue is left in a suitable state after the dinner.

2 First and Third Non-Alcoholic Event Alcohol Policy

- Any member bringing alcohol into a non-alcoholic event will have it confiscated.
- If an attendee is found to be consuming alcohol during the event, they will have it confiscated, be asked to leave the event and not be permitted to attend events for twelve weeks of term time.
- If an attendee is drunk upon arrival for the event they will be turned away.
- Any anti-social behaviour during the event towards other attendees will result in a warning. If the behaviour of the individual continues to disrupt the event they will be asked to leave.
- Any anti-social behaviour directed towards the staff or venue will result in the attendee immediately being asked to leave and the attendee not being permitted to attend events for twelve weeks of term time. For particularly egregious offences, this period may be extended at the discretion of the Captain and Secretary by up to sixteen weeks of term time, i.e. resulting in a ban for up to twenty-eight weeks of term time. In the case of any such instances, the Boat Club, additionally, must expect the matter to be reported to the Dean of College as a matter of course.

3 First and Third Alcoholic Event Alcohol Policy

- The maximum quantity of alcohol supplied will be limited to half a bottle of wine per person, or equivalent.
- If an attendee is drunk upon arrival for the event, they will be turned away.
- Any anti-social behaviour during the event towards other attendees will result in a warning. If the behaviour of the individual continues to disrupt the event they will be asked to leave.
- Any anti-social behaviour directed towards the staff or venue will result in the attendee immediately being asked to leave and the attendee not being permitted to attend events for twelve weeks of term time. For particularly egregious offences, this period may be extended at the discretion of the Captain and Secretary by up to sixteen weeks of term time, i.e. resulting in a ban for up to twenty-eight weeks of term time. In the case of any such instances, the Boat Club, additionally, must expect the matter to be reported to the Dean of College as a matter of course.
- Two named members of the Committee will be nominated to ensure that the venue is left in a suitable state after the dinner.
